All dogs covered under this guarantee are by refund of the purchase price or replacement of puppy*. Any expenses incurred on any returned dog or puppy is the sole responsibility of the original purchaser.

All puppies will have received proper vaccinations and worming to date of purchase. All puppies are sold in good health to the best of Valhalla Kennel's knowledge. The purchaser's veterinarian must examine puppies within 14 days. If we do not receive any correspondence within 14 days, we assume the pup is in good health and you are satisfied.

Hip Dysplasia: Any dog purchased from Valhalla Kennels must be x-rayed by 26 months of age. Dogs between 18 and 26 months of age are covered under this agreement.

• Hips must be x-rayed after 18 months of age by a certified veterinarian; the Orthopedic Foundation for Animals must read the radiograph for official diagnosis. Valhalla Kennels may request a second opinion or x-ray and all medical records must be furnished if requested.

• Any dog with a mild Dysplasia evaluation, or a moderate Dysplasia evaluation, may be returned to Valhalla Kennels for the purchase price refund or another puppy. If PURCHASER wishes to keep the dysplastic dog a refund of ½ the purchase price or replacement puppy will only be shipped after proof of sterilization is received

Any dog with a severe Dysplasia evaluation, may be treated by the following:
The dog may be euthanized, with the agreement of Valhalla Kennels and a letter to that effect by a veterinarian. All costs are the responsibility of the PURCHASER. The PURCHASER is then entitled to the purchase price refund or replacement puppy

• The PURCHASER if said dog is sterilized and the sterilizing veterinarian sends a letter to Valhalla Kennels, stating the procedure was done may keep the dog. The PURCHASER is then qualified for a refund of the purchase price.

Hereditary Eye Problems: Any Labrador purchased from Valhalla Kennels must have an eye exam by a certified veterinary ophthalmologist by age 26 months. Dogs older than 26 months are not covered by this guarantee. The results must be sent to the Canine Eye Registration Foundation. A copy of the ophthalmologist's report must be sent to Valhalla Kennels. The ophthalmologist's report must state that the eye defect is of a hereditary nature, and not caused by injury or illness.

- The dog with the hereditary eye defect may be returned to Valhalla Kennels for a purchase price refund or replacement puppy.
- The dog with the hereditary eye defect may be euthanized with the agreement of Valhalla Kennels. Proof of euthanasia must be sent to Valhalla Kennels to receive a purchase price refund or replacement puppy

• Valhalla Kennels does NOT guarantee dogs for anything other than what is stated above, and specifically is not selling ANY dog for breeding purposes. The dog is sold with a full registration, breeding is optional for the PURCHASER, but no other "genetic" issues are covered

• This guarantee is only valid to the original PURCHASER. Any transfer or sale voids guarantee.

• No dog will be guaranteed unless it carries either the Valhalla prefix or the words Valhalla in its AKC registered name. Valhalla Kennels is NOT a **"Registered"** AKC kennel name, and may/must be used in the dog's registered name on the AKC registration form for this guarantee.

• Any dog euthanized without the written permission of Valhalla Kennels is not covered under this guarantee.

*A replacement puppy is defined as a puppy of the same sex, similar coloring, and similar breeding. The puppy will be replaced out of the next available litter and will be ready for transfer at 7 weeks of age.
